Terms of Agreement

- Purchaser's Responsibilities... Provision of Four (4) A.C. Outlets, (120v), Two (2) eight (8) ft. tables. () Other...
- Deposit & Payment... A deposit of \$50.00 is due upon the execution of this contract, unless checked (). Payment for services must be paid in full the day prior to the event or earlier. A \$25.00 service charge will be added should balance not be paid the day prior to the event. Should the Purchaser request overtime on the day of the event the rate shall be \$_____ per hour.
- Cancellation... American Party Company may cancel this agreement only in the event of cause beyond reasonable control. Purchaser may cancel, up to sixty (60) days prior to performance date, in the event of cause beyond reasonable control, by giving American Party Company mandatory written notice, by certified mail, provided; however; that the deposit received until that date is retained for liquidated damages. Should the contract be canceled/breached under sixty (60) days from the scheduled performance date it is fully understood that the entire balance shall be due by the date of the event.
- Breach of Contract... In the event of breach of contract by failure to perform, or be permitted to be performed, or failure to give proper notice of cancellation, the damages recoverable by either party shall be limited to the contract price plus \$250.00 minimum for attorney fees for non-breaching party plus interest, fees and costs. Return checks shall be charge a \$25.00 service fee. All past due accounts are subject to late fees and a 19.9% interest.
- Determination of Contract Rights... This contract shall be construed by the laws of the Commonwealth of Pennsylvania, which are in effect as of the date of this signed contract.
- Liabilities... It is understood that the purchaser will hold American Party Company harmless of all liability for any injuries, damages or losses to Purchaser and or Purchaser's patrons/guests and their property. Purchaser will be responsible for damages or losses to American Party Company persons, equipment or property and personal injury sustained by such persons as a result of actions by Purchaser and/or Purchaser's guests. This contract shall be binding upon and inure to the benefit of the parties thereto and their respective heirs, executors, administrators, legal representatives,
